KATZ JCC MEMBERSHIP POLICY AGREEMENT (3/25)

The following guidelines will ensure you have a quality membership experience at the Katz JCC. Should you have any questions, please contact the Member Services Office at (856) 424-4444 ext. 1194.

All New members require a 60-day commitment. There is a \$99 new member non-refundable initiation fee for all memberships except Parkinson's Connection J-Path, Student, Limited ECE, Limited Fitness and Affiliate categories.

- 1. Membership fees may be paid in full by cash, check, bank draft or credit card; or in monthly payments by automatic bank draft or credit card debit. Members must provide a monthly form of payment (credit card or bank account). The Katz JCC requires prompt notification of credit card expiration, loss or change. Members are required to provide the Member Services Office with updated billing address and contact information at all times. All membership privileges are suspended if payment is not made. Members are obligated to pay all fees in accordance with the terms of this contract.
- 2. Participation in the Sari Isdaner Early Childhood program requires a 12-month JCC full facility family or limited membership.
- 3. Cancellation Policy: All memberships require a 30-day notice of cancellation. All approved requests will be effective 30 days after receipt of the cancellation notice. Cancellation form may be obtained by visiting www.katzjcc.org/join
- 4. Memberships with special pricing require a 12-month commitment except for medical issues and relocation (must provide valid doctors note or proof of new address). Cancellations within the 12-month sales agreement are subject to a \$50 cancellation fee.
- 5. All members over the age of 2 must have a photo taken for their permanent Katz JCC membership ID. This ID must always be presented for access to facilities. All members under the age of 12 must always be accompanied by an adult or guardian over the age of 18 when on the premises.
- 6. Lockers are provided for member use. However, members are responsible for providing their own locks. The Katz JCC does not take responsibility for lost or stolen articles. Locks may not be left on overnight in our general locker rooms. Signature members receive a private locker in our adult locker room for overnight storage of items (locks not provided).
- 7. Cell phone camera usage is prohibited in all locker rooms (Adult, General and Family).
- 8. The Katz JCC reserves the right to suspend or revoke programs or membership privileges of members or guests whose behavior is deemed inappropriate or detrimental to the well-being of members or staff. Upon revocation of membership, the JCC reserves the right to retain any program or membership monies.
- 9. Memberships are non-transferable and no refunds are granted for non-use of facilities.
- 10. Memberships renew monthly unless paid in full. Paid in full accounts do not automatically renew, these accounts will be invoiced 12 months from there purchase date on a yearly basis. Notification of non-renewal is required at least 30 days prior to expiration date.
- 11. Use of the facilities after written cancellation or membership expiration constitutes automatic renewal, method of payment will be charged automatically. Member is responsible for all fees for the next term of membership.

- 12. The Katz JCC has permission to use images of any members in solicitation, advertising and agency activities unless otherwise notified by the primary account holder. The Katz JCC is open to all regardless of race, religion, sexual orientation, and national origin.
- 13. Whenever possible, no one is turned away from the JCC because of inability to pay. Applications for financial assistance must be completed annually to be eligible for aid. Contact the JCC Financial Assistance Administrator at ext. 1103.
- 14. Guest Policy: Each member 12 and up receives 2 complimentary guest passes per month. Additional guest passes are \$15 per guest with a maximum of 3 visits for any one guest. All guests under the age of 15 are required to receive a fitness center orientation prior to being permitted to access the fitness center. Appointments can be scheduled at our fitness center desk or by calling (856) 424-4444 ext. 1141.
- 15. Local Guest Policy: Local residents may only be a guest 3 times per year. Guests must be accompanied by a JCC member, pay appropriate guest fees as necessary, and sign a guest consent and release form.

KATZ JCC CODE OF CONDUCT (3/25)

Katz JCC Code of Conduct Edited March 2025 the Katz Jewish Community Center (JCC) in Cherry Hill, New Jersey is committed to providing a safe and welcoming environment for all members, guests, and staff.

To ensure the safety and security of all, the JCC requires individuals using the facilities, or participating in our programs to conduct themselves in a considerate and responsible manner, and to respect the rights and dignity of other members, guests, and staff.

We invite all individuals entering the JCC facility or attending a JCC sponsored activity to conduct themselves in a manner consistent with a family atmosphere.

Disruptive, derogatory, and offensive behavior will not be tolerated in our facility. Members and/or guests shall not engage in any disruptive actions, including but not limited to:

- Angry, violent, or vulgar language, including swearing, name-calling, shouting, or any other conduct of an inappropriate, threatening or offensive nature.
- Any behavior that can be perceived as combative, argumentative, or a potential safety risk.
- Any unwelcomed interaction with other members or staff.
- Physical contact with another person in an angry, hostile, or threatening manner.
- Any demonstration of sexual harassment, activity, or conduct with another individual.
- Any harassment, derogatory, offensive conduct or language, including jokes, slurs, pranks, epithets, or other verbal conduct, related to race; color; pregnancy; childbirth or related medical conditions; religion; gender identity; national origin; age; sexual orientation; disability or handicap including perceived disability or handicap; veteran or service member status; marital status; citizenship status; genetic information; or any other category protected by federal, state, or local law.

All members, guests, caregivers, and staff using the facilities or participating in our programs are expected to abide by the following policies:

- Each person entering the JCC is required to present their membership card at our access control scanning stations, door panels and/or sign-in through our guest check-in desk available in the lobby.
- When a non-member signs in at one of the guest check-in kiosks, they must also provide proof of identification to the JCC member service representative and fill out a guest pass.
- Guests may not access the JCC more than three times per calendar year without paying a guest fee.
- Members receive two guests passes per month; any additional guests will be charged \$15 per visit within the month for guests 13 and older, and \$5 per for guests between 3 and 12. Families pay a maximum of \$40 per day.
- All non-member visitors to affiliate services such as Virtua Physical Therapy should sign in on the sign-in book.
- The JCC is a multi-use facility; attire appropriate to the activity is required at all times.
- Any suspicious or inappropriate behaviors must be reported to the JCC staff or security personnel.
- Members and guests should not hesitate to notify a staff member if assistance is needed.
- Packages or bags shall not be left unattended at any time. Members and guests are to report any unattended packages to the JCC staff or security personnel.

- Cars, bicycles and other transportation should be parked in designated areas at all times and secured properly.
- Children may begin using the basketball gym with a parent at age eleven (11) and unattended at age twelve (12).
- All members and guests must adhere to emergency procedures and protocols instructed by the JCC security team and staff (i.e., fire drills, tornado drills, etc.). Tampering with, disabling, or disarming an alarm system (i.e., fire alarm or smoke detector) is strictly prohibited.
- The following behavior is prohibited:
 - o Theft or behavior that results in destruction of property.
 - Carrying or concealing any weapons, devices, or objects that may be perceived as weapons; with the exception of law enforcement and authorized JCC Security personnel.
 - Smoking, vaping, or the use of e-cigarettes or chewing tobacco inside the building or outside on the grounds of the JCC. The JCC and its property are smoke-free environments.
 - Manufacturing, selling, distributing, dispensing, possessing, using, trading, offering for sale, or offering to buy illegal or prescribed drugs, or otherwise engage in the illegal use of drugs, or unsupervised consumption of alcohol beverages on JCC property, or at JCC sponsored events/programs.
 - Children in fifth (5th) grade or younger must not be left unattended under any circumstances on JCC property.
 - Solicitation of any kind on JCC property.

Membership Suspension or Revocation Membership may be suspended or revoked based on the severity of the violation. This will be determined on a case-by-case basis by the Executive Director and/or Agency leadership when behavior is contrary to the interests, purposes, and good and welfare of the agency, or is determined to be in violation of the rules and regulations of the JCC. Appeals may be made with a written letter to the Board of Directors and will be considered at the following board meeting.

Parents and guardians are responsible for the behavior of their children while using JCC facilities and/or participating in JCC programs.

The JCC reserves the right to deal with violations of the JCC Code of Conduct at its discretion at any given time to include, but not limited to, refusal of service, removal from JCC property, suspension and/or revocation of membership privileges and facility access without refund.

The JCC reserves the right to update the JCC Code of Conduct without prior notice to JCC members, guests, and staff and the most current version will be posted on the JCC website.
